



Dear Resident Permit Holder:

Resident permits are available to individuals who reside within the boundaries of the Town of Orangetown. The purpose of the permit is to identify Orangetown residents to golf course personnel. The benefits of this permit are as follows: Greens fee rate discounts, advantages for preferred tee times for weekdays and weekends and senior citizen and youth discount programs. **ALL PERMIT HOLDERS ARE RESPONSIBLE FOR UNDERSTANDING THE RULES OF GOLF, ETIQUETTE OF THE GAME AND MOST IMPORTANTLY PACE OF PLAY.** Failure to follow these rules can result in permit revocation and suspension of playing privileges.

ALONG WITH THE PROOFS BELOW, PLEASE BRING YOUR 2025 BLUE HILL RESIDENT CARD TO BE UPDATED

The following proofs of residency are necessary at time of permit registration (must show name and current address):

- Valid New York State Photo Driver's License or other Photo ID with address. Non-drivers can show Passports, School I.D., but must provide three additional items with current address.

AND TWO OF THE FOLLOWING TYPES OF PROOF:

- Previous year W-2 Tax Form, Current property tax bill, rental agreement showing residence, voter registration card, credit card bill, utility bill, cable TV bill, and current vehicle registration and insurance card may count as one.

****TOTAL OF THREE PROOFS MUST BE PRESENTED FOR PERMIT!!**

(Youth w/ parents must provide one proof, such as school ID or recent report card)

Resident Adult:	\$70.00	(Ages 18-59)
Resident Senior Citizen:	\$60.00	(Ages 60+) - Proof of Age Required
Resident Youth:	\$35.00	(Ages 12-17) - Proof of Age Required
